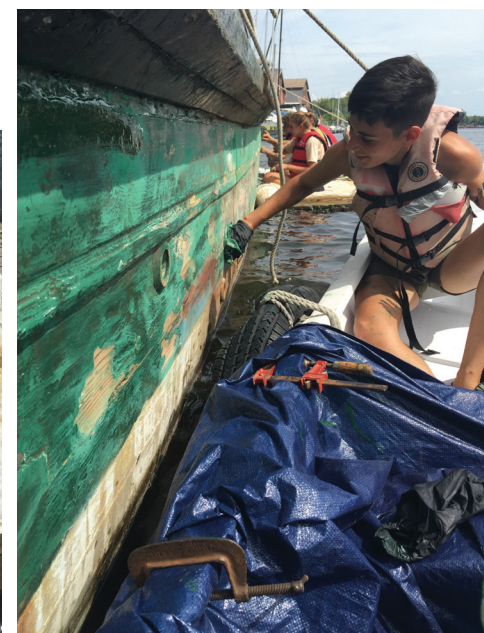

## Clearwater's Second... Annual Gala!

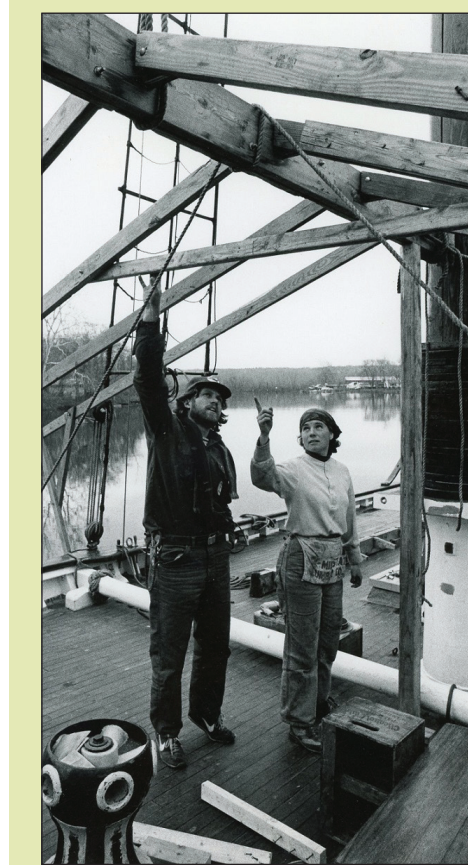

## Clearwater's Second Generation!

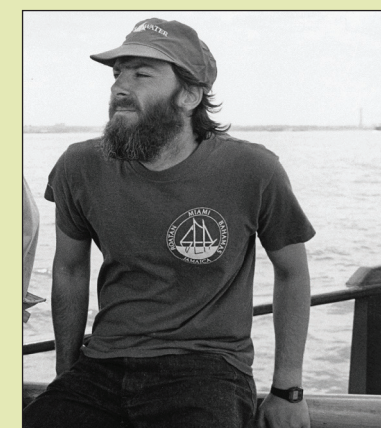

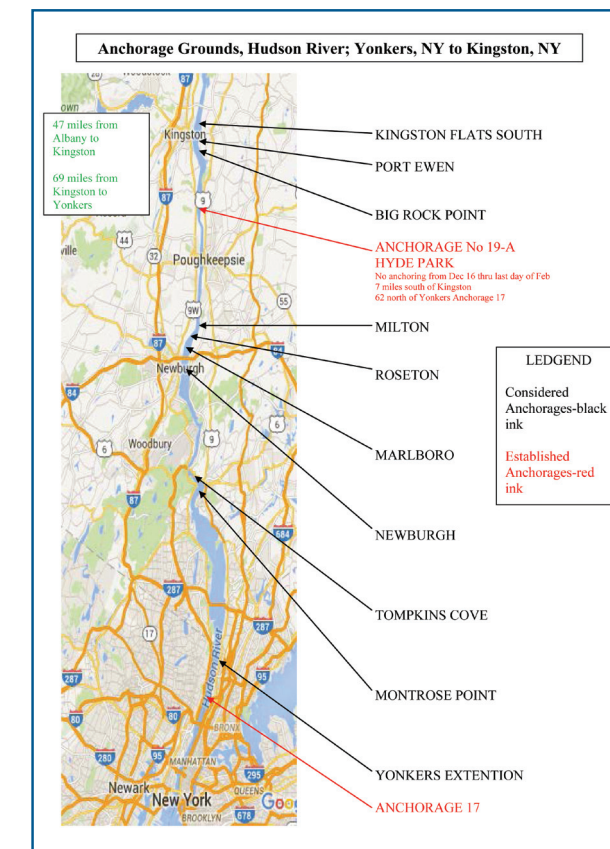


## HUDSON RIVER SLOOP CLEARWATER

### Environmental Action Update:

**Indian Point:** In the past year Indian Point experienced eight unplanned shutdowns, including a major leak of tritium and other radioactive isotopes, and the discovery that 227 baffle and former plate bolts inside Unit -2's reactor core were loose, rusted, broken or missing. These have since been replaced, but IP Unit-3, with identical equipment, has not yet been inspected, let alone repaired. 2016 also saw the passage of NY State's Clean Energy Standards to ensure 50% renewable energy generation by 2030 (Yay!), but also included a massive nuclear subsidy of \$7.6 to \$10 billion (with a "B") to keep New York's aging and unprofitable nuclear fleet operating for another 12 years ("Boo"). While working tirelessly to help close Indian Point, Clearwater is also actively promoting the transition to a renewable energy economy, which the Public Service Commission's nuclear subsidy will unfortunately delay. On another positive note, on November 21 the State of New York Court of Appeals ruled that the Entergy's application related to Indian Point's license renewal is indeed subject to consistency review NYS Department of State, which has already determined that it is not consistent with the State's Coastal Management Plan.

**Hudson River PCB Clean Up:** Clearwater continues to participate in the Community Advisory Group (CAG) for the PCB remediation, which is now focused on the floodplains in the upper Hudson. We are also participating on EPA's 5-yr review team to evaluate what we believe was not the comprehensive clean up of the Hudson River deserves. In August, Governor Cuomo and NYS DEC Commission Basil Seggos issued a strong statement of support for a more robust clean up of Hudson River PCBs and announced that the Canal Corporation will soon begin navigational dredging. This is a major step forward in this ongoing saga.



### Clearwater Challenges New York State Nuclear Subsidy

This year Governor Cuomo and the NY State Public Service Commission (PSC) launched a plan to bail out old, unprofitable nuclear power plants upstate to the tune of up to \$10 Billion – and they want New Yorkers to pay for that bailout with a surcharge on their electricity bills. Nuclear energy is not our future – it's dirty, expensive and dangerous. We deserve clean, affordable and renewable energy. This plan, spelled out in Tier 3 of the so-called Clean Energy Standard, is like subsidizing the horse-and-buggy industry while Henry Ford is rolling cars off the assembly line. On November 30, Clearwater and Goshen Green Farms submitted a landmark case

challenging the PSC's August 1 ruling, which would force NY ratepayers to underwrite an aging nuclear fleet for the next 12-years, as more and more high-level nuclear waste is generated, for which there is no good solution for storage or disposal. Four of these reactors are located in western NY, but the Tier 3 nuclear subsidy could apply to Indian Point Units 2 and 3 as well. Because nuclear power is NOT clean and can certainly not be called emission-free, this challenge is precedent-setting for the entire nation. Stay tuned for details as this historic lawsuit unfolds.

### Aquatic Invasive Species:

Aquatic invasive species (AIS) are still a looming threat in the Hudson River, but with our member support and the participation of over 3,000 boaters we were able to prevent Eurasian watermilfoil, water chestnut, and more species from spreading further inland in the Hudson Valley and elsewhere in the state. Our AIS Program wouldn't have been such a success without funding from the Lower Hudson Partnership for Regional Invasive Species Management and the NYSDEC, and all of your support!



### Coast Guard Announces Proposal for Ten New Anchorages on the Hudson River:

The 10 proposed anchorages, located between Yonkers and Kingston, will include 43 sites for mooring huge tankers and barges filled with highly volatile crude oil – turning the Hudson, which has taken almost

50 years to clean up, into an industrial parking lot. This proposal has generated a lot of concern from Hudson Valley residents, businesses, boat and yacht clubs and municipalities. The Advanced Notice of Public Rule Making (ANPRM), which is similar to a preliminary scoping session, will be followed by a full Notice of Public Rule Making (NPRM) in the Spring of 2017. 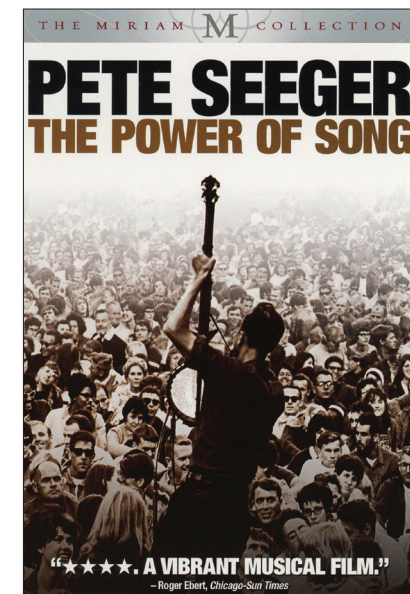

# From The Helm



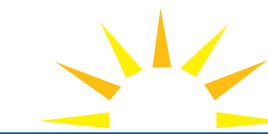
