Call to Order

The annual meeting on Sunday, September 22, 2019 of Hudson River Sloop Clearwater, Inc. was called to order at 10:00AM by president Stephen Smith.

A quorum was determined to be present.

Stephen Smith and Sarah Underhill led the attendees by voice and guitar in group mission song, "River" by Bill Staines.

The meeting agenda was made available online and physically on each table by the Secretary as well as at the sign-in desk by Erin Macchiaroli.

Prior Meeting Minutes Approval

Stephen requested that the Board members approve minutes from the last meeting.

Stephen called for a **MOTION**: To approve the meeting minutes from Tuesday, August 20, 2019 at 10:10am. The **MOTION** was seconded by Sarah. The **MOTION** was **APPROVED UNANIMOUSLY**.

Introductions

Stephen led the meeting after prior meeting minutes approval by introducing Executive Director, Greg Williams to begin with annual meeting opening remarks.

Greg spoke about pronouns as being a part of introducing people by name. It is intended to start a discussion and undermine the notion that we should all just make assumptions. Stephen thanked the staff on behalf of the Board as well as appreciation for Greg Williams.

Education Department Report

Erik Fyfe presented on Education for Clearwater. This year we've had 101 education sails. Education happens at every level of the organization. Volunteers, staff and crew all serve as educators as well as learn every day.

Some of our Programs include: (41 Programs for 2019 thus far)

- 1. Tideline Discovery Program (Running until end of October)
- 2. Professional Development Program
- 3. Youth Empowerment Program (Summer 3 Multi-Day Programs)
- 4. Climate Change Curriculum (Integrating Local Planning and increasing our involvement) (Working on Micro-Plastics as well)

Erik encouraged people to come volunteer on-board and/or reach out to Eli to find out how to become a contract educator or if you have kids in school, talk to someone there and let them know about Clearwater's programs and get them involved.

Environmental Action Report

Henry Neale, temporary Chair of the Environmental Action Committee, introduced Manna Jo Greene. He talked about our continued goal to make the Hudson River Valley a cleaner, healthier and more viable place for everybody. Everyone is encouraged to participate.

[Manna announced there was 20 minutes until the ballot would be closed and to please vote if you haven't]





Manna Jo Greene presented on Environmental Action for Clearwater. 3 Categories included:

- 1. Water Protection
- 2. Watershed Protection
- 3. Hudson River PCBs

Signing petitions makes a difference. Over 3,000 signatures were collected and a team was put together to reach the agencies and elected officials.

Clearwater is working closely the Newburgh Clean Water Project to get the contamination cleaned up out of the water supply.

Indian Point National Decommissioning Group: we are working on a Citizen Advisory Board and hope in the coming year this will come together. Regional and national calls are being made with people who are decommissioning across the country; around 90 or so reactors are either in the process of being decommissioned or are facing decommissioning. Making sure this is done safely is really critical. A cost/benefit risk analysis is being put together by several people (with Bob Alvarez) to present to officials so risk is being considered and discussed.

Coordination strengthens our ability to get Congress (only one who has oversight over the Nuclear Regulatory Commission) to take responsibility.

October 10, 2019 there is a regional decommissioning forum to educate our elected officials and other decision makers.

A national summit in November 2019 in NM will also take place. Climate change and youth was mentioned as well.

Bob Alpern spoke about how Manna Jo Greene's efforts and everyone's involvement could save the world. We should be proud of this organization for the national and international leadership that it is providing.

Financial Report
