For 50 years, Clearwater has been a place where young people join

together, haul on the halyards, and gather in song with crew, volunteers, and students aboard the historic sloop. Today, many of our sailing crew and volunteers often come straight from high school or college and are thrust into real-world challenges of teaching young minds, performing hard physical labor in all weather, carefully navigating intentional community living, and having necessary conversations around gender identity, institutional racism, and environmental justice around meals.

It was a group of very young, inspired, and activated people who raised money to lay the keel in 1968, sailed the fine sloop *Clearwater* on her maiden voyage

in 1969, and started an environmental revolution right here on the Hudson River that rippled across waters around the globe. Clearwater continues to encourage individuals to form their own bond with the Hudson River through personal experience. Clearwater puts learning in the hands of each student as they get to touch fish, haul on lines, set seine nets, clap or sing along with river songs, and create works of art inspired by the Hudson.

Our nation is bearing witness to a revolution lead by a generation who has new ideas, high standards, an urgency for reform, and momentum that will guarantee a better tomorrow. Pete Seeger had

> great faith in humanity to come together, and especially trust in young people, to muster up the strength and ingenuity needed to protect the Hudson River and save the world. We continue to hear the echoes of his words in the chants and songs pouring forth from the lips of children and young adults stepping up to demand a better future for themselves.

We gather at the Hudson River, casting nets into the turbid waters and hauling in schools of energetic Young-of-the-Year fish on their first migrator path up the estuary. But this spring, we are awestruck by promise for change led by students across the nation during this astonishing Year-of-the Young. We

applaud this extraordinary effort paralleled by young fish and young leaders as you show us what can be achieved when you struggle against the current and triumphantly overcome.

Education Saturation

On May 18th, Clearwater will be working with students throughout the valley, From Riverdale to Esopus Meadows, on the sloop, in the classroom, and by the shore.

The grand total is 270 students on one day. May 18th highlights the many aspects of our program available to students. Educators

will bring fish and invertebrates to the Riverdale Country Day School 3rd graders as part of their year-long study of the Hudson River, which includes classroom visits and a sail on the *Mystic Whaler*. This is our 4th year of working with the school.

The Meadow Pond School in South Salem NY will have 2 trips on the *Clearwater*. While the morning group sails, we will work with the other group at



their school, offering our Power of Song and our Water Pollution Cleanup program. The Power of Song uses songwriting as a way of creating social change and inspiring the students to act on issues that concern them. Our hands-on pollution activity examines how we pollute our water, how we clean it, and how we could do better. When the morning sailing group returns we will work with them as well.

At Esopus Meadows, the Orville Todd Middle School from Spackenkill, NY will join us. We have worked with this school so many times that the teachers insist on running the seining station

for their students. It is great to see the interactions between the students and teachers, as the challenges of fishing with a net are quite different from their classroom relationship.

This day encapsulates Clearwater's goals to educate, activate, and inspire. Educate on the life of the estuary, activate students to protect

the environment, and inspire them to appreciate the beautiful and complex system that is our beloved Hudson River.

HUDSON RIVER SLOOP CLEARWATER Environmental Action Is Making a Real Difference

The Hudson River continues to face many challenges and opportunities, which Clearwater's Environmental Action Program has creatively tackled by educating decision-makers and community members, promoting consensus-based solutions, where possible, and by filing legal actions where necessary.

NO TO ANCHORAGES – YES TO SAFETY: This year we have seen widespread opposition and unprecedented public comment from a broad coalition of Hudson River organizations and municipalities effectively stop the proposed ten additional anchorages between Yonkers and Kingston, which would have housed up to 43 vessels filled with highly-explosive crude oil. Following a series of facilitated workshops, the Coast Guard issued its Ports and Waterways Safety Assessment (PAWSA) Report in March and has created a Hudson River Safety Committee (HRSC) to recommend practices that will ensure the safety on our iconic waterway into the future.

INDIAN POINT: Promoting Safe Decommissioning. Indian Point's aging reactors, Units 2 and 3, are scheduled to close in 2020 and 2021, respectively. Given its track record of transformer explosions, degraded bolts, leaky O-rings in both reactors and a crack in the reactor head



of IP-2, Indian Point's closure is an important step to reducing a major threat to the Hudson River. However, with more than 1,500 tons of high-level waste stored on-site in severely overcrowded fuel pools or in vulnerable dry cask storage, much still needs to be done. We are also working with local elected officials to establish a Citizens' Oversight Board to ensure effective input to achieve the safest possible, fully funded decommissioning plan and a Just Transition for plant workers.

CLEARWATER'S LEGAL CHALLENGE TO NY'S NUCLEAR SUBSIDY IS UNDERWAY: For the past year.

Clearwater, NIRS, IPSEC and others have challenged the NYS Public Service Commission's 12-year mandatory \$7.6 billion (with a "b") subsidy to bail out aging nuclear plants in western NY, which are no longer economically viable on their own. Unless stopped, these plants will continue to generate hundreds of tons more of highly-radioactive nuclear waste, for which there is no disposal solution. Our petition has survived motions to dismiss, and this landmark case is now headed to hearing, but we need your support to ensure victory in this classic David vs. Goliath challenge. PCBs – Only A Partial Victory: Clearwater and our sister organizations, several State and Federal agencies, and many municipal officials have called for a more robust PCB clean up that will allow the Hudson to recover more rapidly. We believe that the remediation that EPA has required of GE is NOT adequately protective of human health and the environment. Recently EPA delayed issuing a Certificate of Completion for this phase of the dredging and agreed to help DEC analyze their extensive data – both steps in the right direction – indicating that public pressure is having some positive impact.

Watercraft Inspection Steward Program (WISP)

Watercraft inspection stewards are becoming more common across New York and the United States as invasive species become a more widely recognized environmental problem. One of the most common modes of spread for aquatic invasive species is via boats, trailers, and boating equipment. Many species can survive for extended periods outside of water, giving them countless opportunities to "hitchhike" from one waterbody to another. These stewards help to prevent the spread of aquatic invasive species at the source.

The Watercraft Inspection Steward Program (WISP) was started at Clearwater in 2015, and during the 2017 season Clearwater expanded the program from two stewards to three that each worked four days/week. 583 boats were inspected and over 1,400 individual boaters were reached. Overall, 89 percent of boaters were willing to participate in inspections and 70 percent were aware of the Clean, Drain, and Dry protocol. Only 9 percent of boats harbored aquatic hitchhikers!

The 2018 season brings another exciting expansion to the WISP. This year, 4 stewards will be stationed at the Croton, Highland, Staatsburg, and Kingston boat launches from May to September from Friday-Sunday and on holidays. Additionally, this season Clearwater has partnered with the New York-New Jersey Trail Conference to host the Lead Boat Steward through the prestigious AmeriCorps program from April to October. The Lead Boat Steward will travel to several different launches throughout the season, as well as survey New York water bodies for aquatic invasive species, assist the Invasive Species Program Manager, Samantha Epstein, with trainings and presentations, and even lead two group volunteer survey trainings at Annsville Creek with kayaks provided free of charge for volunteers by Hudson River Expeditions! The Invasive Species Program also offers free training on AIS identification to lake associations and marinas.



MEMBER SPOTLIGHT: Hy Yellin (1923-2018)



Every so often at Clearwater, we receive heartfelt messages about how this organization has touched people's lives. Below is a recent letter we received from member Bill Yellin, whose father Hy (Herman) Yellin passed away in January.

Hello, Sloop Clearwater,

You may have gotten donations over the past few weeks in memory of Hy (Herman) Yellin, who passed away

on January 24th at the age of 94.

I thought you should know why these were coming to you. My Dad followed me into your organization in the early 1990's after the death of my mother, his life-long soulmate. Looking for something to do, he found it, and a home for a while in Clearwater.

In his 70's, he volunteered at the Revival for several years, picking up garbage and grumbling at kids, happy as a clam.

For a few summers, he helped onboard the sloop when he could. Did a few week-long tours, and every now and then I would hear that the crew had spotted him in lower Manhattan and shang-hai'd him into service for an afternoon sail. Note that I heard this from both him (complaints) and crew members after the fact, happy as hell to have found him.

Eventually, life caught up with him, age, arthritis and a diminishing capacity to relate to other people's kids, and he faded from Clearwater.

Anyway, that's who he was, and that's why when people have asked what they can do in his name, we've said "Clearwater." Maybe you got something, maybe not, but I thought you should know.
